## BECAUSE THIS WARNING

This page describes the purposes and methods of managing the site (hereinafter "Site") about the processing of personal data of users who consult it.

This information is provided in compliance with the provisions of Article 13 of European Regulation (EU) 2016/679 (hereinafter "GDPR"), with which Memc Spa (hereinafter "Company"), in its capacity as data controller, in the person of its legal representative pro tempore, informs all those who interact with the pages of the Site from the address:

corresponding to the initial pages of the Company's official websites.

The information is provided only for the sites mentioned above and not for other websites that may be consulted by the user through links from these. It should be noted that the Company assumes no responsibility for the websites of third parties.

The information is also based on Recommendation no. 2/2001 that the European Authorities for the protection of personal data, gathered in the Group established by art. 29 of Directive no. 95/46/EC, adopted on 17 May 2001 to identify certain minimum requirements for collecting personal data online, and in particular the manner, timing and nature of the information that data controllers must provide users when they connect to web pages, regardless of the purpose of the link.

## WHO IS THE DATA CONTROLLER?

Following consultation of this Site, data relating to identified or identifiable persons may be processed.

## **WHERE ARE THE DATA PROCESSED?**

The processing operations connected to the web services of this Site take place at the aforementioned Company and are carried out only by technical personnel, or by persons in charge of occasional maintenance operations. No data deriving from the web service is communicated or disseminated outside the company. The personal data provided by users who request information are used only to perform the service or provision requested and are communicated to third parties only if this is necessary for that purpose.

## **WHAT TYPES OF DATA ARE PROCESSED? FOR WHAT PURPOSES ARE THEY PROCESSED?**

Personal data voluntarily provided by the user are collected and processed to allow the Company to provide its services.

### **Navigation data / cookies**

The Company has read the Provision of the Guarantor Authority for the Protection of Personal Data "Identification of simplified procedures for the information and acquisition of consent for the use of cookies" of May 8, 2014 (Published in the Official Gazette no. 126 of June 3, 2014), in accordance with which you wish to inform that its corporate sites mentioned in this statement do not use cookies.

With regard, therefore, only to technical aspects, cookies and protocols, we wish to inform you that:

- The computer systems and software procedures used to operate this Site acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols.
- This information is not collected in order to be associated with identified interested parties, but by its very nature could, through processing and association with data held by third parties, allow users to be identified.
- This category of data includes IP addresses or domain names of computers used by users connecting to the Site, URI (Uniform Resource Identifier) of requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response from the server (successful, error, etc..) and other parameters relating to the operating system and computer environment.

These data are used only to obtain anonymous statistical information on the use of the Site and to check its proper functioning. The data could be used to ascertain responsibility in the event of hypothetical computer crimes against the Site.

In any case, the user may use the functionality of each browser to authorize, block or delete (in whole or in part) cookies; in the event that all or some of the cookies are disabled, it is possible that the Site is not available or that some services or certain functions of the Site are not available or not working properly and / or you may be forced to change or manually enter certain information or preferences each time you visit the Site. Specific security measures are observed to prevent the loss of data, illicit or incorrect use and unauthorized access.

## **DATA PROVIDED VOLUNTARILY BY THE USER**

The optional, explicit and voluntary sending of electronic mail to the addresses indicated on this Site entails the subsequent acquisition of the sender's address, necessary to respond to the re-enquiries, as well as any other personal data included in the message.

The data entered when subscribing to the newsletter through the Site or sending requests through the form on the same, will be acquired upon your acceptance to the processing of personal data.

The provision of data is optional, but its refusal will not allow the establishment of the rapport with Memc Spa. and participation in initiatives reserved for registered users.

Please note that these data will be kept within and no later than the period necessary for the execution of the request.

## **DID YOU KNOW THAT THE PROVISION OF DATA IS OPTIONAL?**

Apart from that specified for navigation data, the user is free to provide the personal data re-ported in any information request forms.

Failure to provide such data may make it impossible to obtain what has been requested.

## **WHAT ARE THE RIGHTS OF THE INTERESTED PARTIES?**

The subjects to whom the personal data refer have the right at any time to obtain confirmation of the existence or otherwise of such data and to know its content and origin, verify its accuracy or request its integration or updating, or correction (Articles 15-22 of the GDPR), having the right to request cancellation, oblivion, transformation into anonymous form or limitation to the processing of data processed unlawfully, and to oppose in any case, for legitimate reasons, their treatment.

## **HOW TO CONTROL COOKIES?**

Disabling cookies:

### **Internet Explorer 8.0+:**

Drag the slider to "Block all cookies".

### **Firefox 4.0+:**

Click on "Tools" in the menu bar

Select "Options"

Click on the "Privacy" tab

Check the box "Enable anti-tracking of personal data".

### **Chrome:**

Click on the "Chrome menu" in the browser toolbar

Select "Settings".

Click on "Show advanced settings".

In the Privacy section, click the "Content Settings" button

In the "Cookies" section, select "Ignore exceptions and block the setting of third-party cookies".

### **Safari 5.0:**

Click on the Safari menu and select "Preferences".

Click on the "Security" tab

In the "Accept cookies" section, specify whether you always want to accept cookies, never or only from the sites you visit. For an explanation of the different options, click the Help button in the form of a question mark. If Safari is set to block cookies, you may need to accept them temporarily to open the page. Then repeat the steps above and select "Sem-pre". Once you have finished using the guide, disable the cookies again and delete them.
